- Preparing information for parent review and input, and
- Discussing the barriers to involvement and strategies for increasing family engagement.

- Encouraging parents to attend and participate in Individual Learning Plan (ILP) conferences, and
- Communicating through printed notes, call outs, email, and social media.

**Sunset School will coordinate with other Federal, State and local programs that encourage and support parents in educating their student by:**

- Providing information on Head Start, community centers in Davis, Davis Technical College (DTC), etc., and
- Providing classes and services as needed from Family Services to assist students and families.

**Sunset School will ensure that the policy and information related to school programs, meetings, and activities is sent home in a format and, to the extent practicable, language the parents can understand by:**

- Translating the policy and key documents,
- Posting translated documents on the school website, and
- Updating documents periodically as needed.
